Subject: Nashville Alumnae Chapter Scholarship Opportunity

Dear Applicant,

Delta Sigma Theta Sorority, Inc. is a private, international public service sorority comprised of more than 300,000 predominantly African American, college-educated women. Since its founding in 1913 on the campus of Howard University in Washington, D.C., Delta Sigma Theta Sorority, Inc. has established itself as an organization that seriously considers the issues impacting the Black community and boldly confronts the challenges faced by African Americans and, hence, all Americans. The Nashville Alumnae Chapter (NAC) of Delta Sigma Theta Sorority, Inc. assists African-American female students in attaining their post-secondary education goals through our annual scholarship program. Scholarship Applications are now being accepted for the 2026-2027 academic school year. You will find below additional information regarding eligibility requirements and the application process.

Applicants must meet the following criteria:

- Be an African American female senior who resides in and attends school in one of the following six (6) counties: Cheatham, Davidson, Robertson, Sumner, Wilson, or Williamson.
- Complete and sign an application and photo release and attach a current professional photo.
- Have a minimum cumulative unweighted GPA of 3.0 on a 4.0 scale.
- Submit an official high school transcript. The transcript must include seven (7) semesters of grades and coursework, current classes, and ACT/SAT scores. Transcripts must be submitted directly by the school counselor from their official school email account. Student or parent submitted transcripts will not be accepted.
- Complete a typed three hundred (300) to five hundred (500) word essay (details provided on application).
- Submit two letters of recommendation (details provided on application) using official letterhead signed in pen/ink (digital signatures acceptable).

Packets including transcripts and recommendation letters must be electronically submitted to scholarsnac@gmail.com by Sunday, March 15, 2026. Incomplete applications will not be accepted.
